# 10am: Welcome to the Meeting

Welcome addresses (Ciampi, director ITTIG; Greenleaf, co-director AustLII) and introduction to attendees (Tiscornia)

## Alternative models for multi-country free access to law (Chair: Peruginelli)

Presentation by AustLII (Greenleaf, Mowbray & Chung):

Issues to be covered include the differences between centralised, 'federated' and hybrid models of multi-country legal information systems (LIS); the difference between active and passive permissions and cooperation, and hybrid models; existing European examples of multi-jurisdictional LIS (including national and supra-national jurisdictions); models outside Europe; absence of legal and technical impediments to obtaining European data; and a demonstration of the European Law Project in WorldLII (funded by the Australian Research Council 2011-12) and a 'EuroLII' prototype.

Based on the previous presentation, a discussion of what models for a European-wide LIS might be effective and sustainable in Europe; Issues include range of documents desirably included, methods to deal with linguistic diversity, extent of official cooperation likely to be achieved etc; Views to be sought from attendees.
